Program Eligibility

A. Definition

Forage re-seeding is the method of re-establishing adapted and/ or compatible species, varieties, or cultivation of herbaceous species suitable for hay land.

B. Purpose

Forage re-seeding is important to improve or maintain livestock nutrition and/ or health. It can provide or increase forage supply during periods of low forage production. Also, by reseeded hay land it can reduce soil erosion and improve soil and water quality. Optimal planting dates are August 15 to September 15 or March 15 to April 15.

Policies for Practice

1. Application for this practice will be available **June 22, 2020 through August 14, 2020.**
2. Applicant must be a District Cooperator.
3. A W-9 tax form will be required with application for District tax purposes.
4. Cost share is available to owner or lessee.
5. Applicant must provide map identifying tract and field along with proposed acreage.
6. Applicants must also provide soil test results for field applied.
7. Soil sample results must be within past 3 yrs.
8. NRCS standards and specs must be followed.
9. Approvals will be final at PVCD **August and September meetings – first Wednesday of the month, unless otherwise indicated.**
10. Application approvals will be made based upon availability of funds and based on the ranking form.
11. After approval applicant must follow job sheets provided at the time of signing the contract.
12. Invoices must be submitted by **May 28, 2021 at 4:00PM.**
13. No duplication of federal or state dollars shall be allowable.
14. **HAY FIELDS ONLY**

C. Payment rates & limits:

1. The cost-share for this practice shall be at a \$50.00 per acre, a maximum of \$2,500.00 per applicant.
2. Maximum of 50 acres per applicant.
3. The payment will be made within 45 days after paid invoices are received, cooperators complete a W-9 form and the AEP committee has made a site visit.
4. No duplication of federal or state cost-share shall be allowed.

D. Practice Specifications

1. NRCS standards and specs must be followed. (Table 1: Seed Mixtures and Rates Per Acre.)
2. After approval applicant must follow job sheets provided at the time of signing the contract.
3. **Methods of seeding must be no till in to existing stands.**
4. Lifespan of this practice is 2 years.
