Program Eligibility

A. Definition

Bale Grazing is a method of setting winter feed (typically round bales) out ahead of winter feeding, when the soil is dry or frozen, and controlling the portions of feed the livestock have access to on a bi-weekly or more frequent basis, similar to strip grazing stockpiled forages in the fall. Livestock access is controlled with temporary fencing (polywire, high tensile wire, step in posts, t-posts).

B. Purpose

Bale Grazing will incentivize producers to consider an alternative to traditional winter-feeding practices. Similar to Stockpile Grazing, Bale Grazing is an alternative winter-feeding option that utilizes parts of the farm that typically are not fed on in the winter months.

C. Policies for Practice

- 1. Applicant must be a District Cooperator.
- 2. Cost share is available to owner or lessee.
- 3. Applicant must provide map identifying tract and field along with proposed acreage.
- 4. Cooperator is limited to 2 (two) practices plus 1 (one) lime program per fiscal year.
- 5. Cooperator cap is \$4,000.00 (Four-Thousand Dollars) per fiscal year.
- 6. Application approvals will be made based upon availability of funds and based on the ranking form.
- 7. After approval applicant must follow job sheets provided at the time of signing the contract.
- 8. "Applications received by 1st (first) of every month are typically placed on that month agenda."
- 9. 1st round invoices must be submitted by December 1st, 2024. 2nd Round: June 1, 2025.

D. Payment rates & limits:

- 1. The maximum cost-share for this practice shall be 50% up to \$750.00.
- 2. The payment will be made after paid invoices are received, cooperator completes a W-9 form and completion of site visit.
- 3. No duplication of federal or state cost-share shall be allowed.
- 4. Capitol Conservation District does not reimburse sales tax amount.
- 5. Approved materials that qualify for reimbursement are Temporary Fence, Temporary Posts, Fence Chargers, and 1 Hay Ring.

E. Practice Specifications

- 1. NRCS standards and specs must be followed.
- 2. After approval applicant must follow job sheets provided at the time of signing the contract.
- 3. Methods of seeding stands may be established either by conventional or no till.
- 4. Lifespan of this practice is one (3) years.
