Program Eligibility

Definition:

The stabilization of area is frequently and intensively used by animals and/or vehicles by surfacing with suitable materials. The base shall be either gravel, crushed stone, or geotextile to provide the site with a need for increased load bearing strength, drainage, separation of material, or soil reinforcement.

Purpose:

To create a stable, non-eroding surface around livestock feeding/watering areas, heavy traffic paths, or farm machinery lanes.

Policies for Practice:

1. Applicant must be a district cooperator.
2. W-9 tax form is required with application for district tax purposes.
3. Cost Share is available to owner and/or lessee.
4. Applicants must provide a map identifying fields and acreages.
5. WVCA standards and specs must be followed.
6. Approval will be considered on _____.
7. Application approvals will be based on ranking form and availability of funds.
8. After approval, applicant must follow job sheet provided at the time of signing contract.
9. Invoices must be submitted by _____.

Payment rates & limits:

1. The maximum cost-share for this practice shall be \$ ____/sq. ft. rate up to \$ ____.
2. The payment will be made after paid invoices are received, cooperator completes w-9, and a verification site visit has been completed.
