### Minutes of the GVCD Special Board Meeting August 17, 2016

The Greenbrier Valley Conservation District Board of Supervisors met on Wednesday, August 17, 2016, at the GVCD office, 179 Northridge Drive, Lewisburg, WV, 24901.

**Supervisors:** Gary Sawyers present; Jerry Clifton, Gary Truex, Avery Atkins, and Carolyn Miller by conference call. Timothy VanReenen was attending an NACD conference in New Jersey.

Others present: Barry Level, Lynn Hutchison

#### Call to Order

Chairman Gary Sawyers called the meeting to order at 9:12 a.m.

#### New Business

This meeting was called to address plans and funding for the State Farm Tour, which will occur one day prior to the regular Board Meeting on August 25, 2016.

Gary Sawyers asked Lynn Hutchison to review the options for a tent for the event. Options were presented as follows:

- 1) Rental \$850.00 for 20 x 40 tent (including delivery, set up/tear down,) tables, chairs, and linens
- 2) Rental \$475.00 for 20 x 40 tent ONLY (including delivery, set up/tear down)
- 3) Rental \$225.00 for 20 x 40 tent ONLY (we pick up and set up/tear down ourselves)
- 4) Rental \$425.00 for 20 x 30 tent ONLY (including delivery, set up/tear down)
- 5) Rental \$175.00 for 20 x 30 tent ONLY (we pick up and set up/tear down ourselves)
- 6) Purchase \$139.99 each plus shipping for 10 x 30 tent (we would have to set up/tear down)

Discussion ensued regarding the pros and cons of each option. It was decided that since the event date is only a week away, it may be too late to order/purchase a tent(s) and receive it on time, so a rental would be best at this time. Size was also a concern on the purchase option. A purchase may be considered for future events when there is adequate time to shop and research. It was decided that only a tent would be rented, as the Canterburys have said they can provide tables and chairs. While it would cost less to set up and tear down a rented tent ourselves, there was concern about having the available help to pick it up and set it up prior to the event and tear it down afterwards and take it back. It was suggested that it would cost as much in staff time and mileage as it would to pay for the set-up. It was also noted

that we would be responsible for any damages that occurred if we took that on ourselves. The larger tent was thought to provide the most protection in the event of inclement weather, in addition to accommodating guests and food tables. For those reasons, it was decided that Option #2, listed above was the best choice. Jerry Clifton moved to rent the 20 x 40 tent only, including delivery, set up and tear down, for \$475.00. Carolyn Miller seconded. Motion passed.

Gary Sawyers asked Lynn Hutchison to review the options for food. Options were presented as follows (for comparable menus:)

1)	Dickey's Barbeque Pit - catering for 50; we pick up and serve	\$647.50
2)	Pickaway Pickins' – catering for 50; full service	\$488.75
3)	Jim's Drive Inn/Wal-mart supplies for cookout for 50; we pickup & prepare	\$500.00 (approx.)

Discussion ensued regarding the pros and cons of each option. Avery Atkins recused himself due to his affiliation with Pickaway Pickins'. It was decided that Option #2, with the lowest cost, as well as, full service, was the best choice. Jerry Clifton moved to hire Pickaway Pickins' to cater the event for 50 at a cost of \$488.75. Gary Truex seconded. Motion passed.

With no further business, the meeting adjourned by consensus at 9:34 a.m.

Hello, all...Gary asked me to share this with you to be thinking about:

Here are some options for a tent for the State Tour at Bill's.

As discussed at the committee meeting, it will cost \$850.00 to do the 20 x 40 tent, tables and chairs, and linens just like the Farm Field Day.

If we rent the 20 x 40 tent ONLY it would be \$475.00 for them to set-up and remove or \$225.00 if we do our own set-up and removal. (Bill did tell Dennis that he could get tables and chairs himself if we got a tent and that it would be really helpful if we could get a tent...)

Gillespie's also has a 20 x 30 tent which is \$425.00 for them to set-up and remove or \$175.00 if we do our own set-up and removal.

Keep in mind that we are responsible for any damages if we do our own set-up and tear-down. Also, we would have to make sure we have the staff/help to do that when the time comes.

The 20 x 40 is said to seat 80 people and the 20 x 30 is said to seat 60 people.

Another option would be to buy one (or more) of our own. Walmart has a 10 x 30 for \$139.99. These are half the width as the ones from Gillespie's, and probably less durable, but are not bad and would be ours to keep. It says it holds up to 50 people but that seems tight.
