### Minutes of the GVCD Regular Board Meeting February 16, 2017

The Greenbrier Valley Conservation District Board of Supervisors met on Thursday, February 16, 2017, in the conference room of the Lewisburg USDA Service Center. Those attending were:

#### Call to Order

Chairman Gary Sawyers called the meeting to order at 7:00 pm.

#### **Approval of Minutes**

Motion was made by Timothy VanReenen and seconded by Jerry Clifton to approve the minutes of the January 19, 2017 Regular Board Meeting and the January 13, January 26, and February 2, 2017 Special Board Meetings. Motion passed.

#### **Guests**

Jeff Hollifield, CPA, of Hollifield & Associates, presented his report for the FY16 Agreed Upon Procedures engagement. His one recommendation was that video conferencing equipment, valued at approximately \$1,887.00 should have been capitalized rather than expensed. There were no other findings. Gary Sawyers thanked him for the report and explained that formal acceptance and payment would placed on the agenda for the next meeting.

Katy McBride shared information about the Grassland Evaluation Contest and Envirothon. She noted that brochures and registration forms could be found on the WVCA website under the "Education" tab and that volunteers are still needed. She also reported that she has had two inquiries about Land Judging. Discussion ensued. It was decided that the topic would be put on the Grassland Committee for March and that we should inquire of SCD if they would be interested in co-sponsoring the event as in the past. Finally, Katy reported that she has a nomination for Conservation Farm for Greenbrier County and will discuss with Barry Level.

### **District Manager Report**

Lynn Hutchison referred to her written report, a copy of which is attached.

Gary Sawyers noted that he had asked Lynn to respond on his behalf to an email from Jordan Maynor regarding Dry Creek and Wades Creek and read the response to the Board.

### **Funding Requests**

- LOR for EWP State Quick Response \$53,526.00 -- Timothy VanReenen moved to send the LOR and Avery Atkins seconded the motion. Motion passed.
- LOR for South Fork of the Cherry River (remaining funds) -\$200,000.00 Carolyn Miller moved to send the LOR and Timothy VanReenen seconded. In discussion, Lynn shared that she had been instructed to send the LOR, but that it would not be processed until all necessary paperwork was received from DEP. Gary Sawyers stated that it would be acceptable to send the LOR as long as no contracts were let before the funds were received. Others agreed. Motion passed.
- OM&R Sponsorship Letters to Greenbrier County Commission, City of White Sulphur Springs, and Town of Marlinton, per OM&R agreements – Timothy VanReenen moved to send the sponsorship letters and Jerry Clifton seconded the motion. Motion passed.

### **Cooperating Agency Reports**

• NRCS – Jack O'Connell

Jack O'Connell reported that they have 225 applications to rank in the three counties. He thanked the Supervisors again for their outreach assistance. He reported the Appalachian Environmental Restoration Initiative (AERI) has been expanded to include all of Monroe County and noted application statistics. He also shared that Susan Davis will be leaving her position with NRCS after 26 years of dedicated service and will be greatly missed. A copy of his written report with more information is attached.

Jeremy Salyer referred to his written report and opted to wait until the end of the meeting to address any uncovered issues.

### **Unfinished Business**

Appalachian Grazing Conference attendance- **Timothy VanReenen moved to approve payment of registration fee for the one interested party, Tootie Jones of Swift Level Farm. Avery Atkins seconded.** In discussion, it was determined that a receipt should be submitted after attendance for reimbursement. It was also noted that no students had expressed an interest in going, but that it was difficult for them to travel that distance during the school week, etc. **Motion passed.** 

### **Committee Reports**

### Finance Committee:

Carolyn Miller reported that she had visited City National Bank regarding updating the names on the Certificate of Deposit there. Gary Truex is the only current Supervisor listed on the CD, so he will have to initiate any changes. Discussion ensued. With the CD maturing on July 4, 2017, it was decided to table the issue to the May meeting at which time it would be decided whether to renew the CD or move the funds to another account with a better interest rate.

- WVCA Restricted Funds Report Timothy VanReenen moved to accept the WVCA Restricted Funds Reports and file for audit. Seconded by Carolyn Miller. Motion passed.
- Payment of all General Funds bills— Jerry Clifton moved to pay all General Funds bills, per payables list, as presented. Seconded by Gary Truex. Motion passed. List is attached.

Timothy VanReenen moved on behalf of the committee to approve all payments. Jerry Clifton seconded. Motion passed.

- There were no cancellations.
- FY18 AgEP Sign-up period Timothy VanReenen moved on behalf of the committee and Jerry Clifton seconded the motion to hold FY18 AgEP Sign-ups for the period of June 1 – June 30, 2017. In discussion it was noted that everything should be tagged "pending available funding." Motion passed.

#### Grassland Committee:

- Information on several options for hats was provided. It was decided that Supervisors would take time to review the options and a decision be made at a later date.
- Conservation Farm Planning was discussed earlier in the meeting with Katy McBride. It was noted that nominations should be ready by April 1.
- Gary Truex reported that the nominal fee we charge does not adequately cover our expenses on soil samples and the committee recommends that postage cost be paid by the cooperator. Gary Truex moved on behalf of the committee and Carolyn Miller seconded the motion to charge cooperators for postage on soil samples. Motion passed.

Building/Equipment Committee:

- At the last meeting, Eric Rose appeared to request the GVCD house rental equipment in Pocahontas County. The matter was taken under advisement for the February committee meeting. Gary Truex reported that after careful consideration and consultation with the equipment coordinator that it was determined that it wasn't feasible to accommodate that request at this time. Gary Truex moved on behalf of the committee and Avery Atkins seconded the motion to keep the equipment location and function as is. Motion passed on a vote of 5-1, with Jerry Clifton casting the dissenting vote.
- Gary Truex reported plans for the office and bathroom construction in the equipment building. Discussion ensued regarding a budget. Gary Truex moved on behalf of the committee to budget up to \$1,600.00 for materials to build the office and bathroom. Motion passed.
- Gary Truex reported that the committee recommended running an ad (per policy) to sell the pasture drag and aerator. Discussion ensued. Carolyn Miller moved to run a legal ad without a minimum bid, but with the right to refuse any/all bids, with a deadline of March 6, 2017, to be opened at the committee meeting on March 8, 2017. Timothy VanReenen seconded the motion. Motion passed.
- Jerry Clifton moved to contact the party who was interested in the storage building and offer it to him for \$490.00. Avery Atkins seconded the motion. Motion passed.
- Gary Truex went over a flyer prepared by Dennis Burns and Eugene Wickline regarding the proposed Equipment Demonstration Field Day. Discussion ensued regarding plans and budget. Timothy VanReenen moved to budget up to \$1,000.00 for the field day. Gary Truex seconded the motion. Motion passed.
- Gary Truex reported that the committee had discussed potential school projects utilizing the potato equipment. Discussion ensued. Gary Truex moved on behalf of the committee and Timothy VanReenen seconded the motion that any youth organization such as FFA or 4-H, be allowed to use the equipment at no cost, provided it was for a fundraising effort. In discussion, it was noted that individual students working on a personal project would still be charged the regular rate. Motion passed. Supervisors will be responsible for letting their county schools know it's available.

- Policy Committee will meet on March 8, 2017 following regular committee meetings. All policies have been sent to Supervisors for review.
- Plan of Work will be placed on April agenda for scheduling of meeting with partners. Meeting is to be held in May or June, per policy.

went over the report. Discussion ensued about several of the individual CCRs. There was a question on dam
inspection dates which will need to be clarified by Judith.

- Timothy VanReenen moved to hold annual GVCD employee evaluations on April 12, 2017, with Supervisors
  meeting at 8:30am, employees joining at 9am, and to change regular committee meetings to 10am. Gary
  Sawyers seconded the motion. Motion passed. Lynn will give self-evaluation forms to employees to complete
  and bring with them to the meeting.
- Jerry Clifton moved to approve up to \$300.00 for a multi-purpose GVCD promotional display. Carolyn Miller seconded the motion. Motion passed.

# NRCS Report – Greenbrier Valley Conservation District February 16, 2017

### Farm Bill Programs

*EQIP/AMA* - Applications for the first-round of EQIP/AMA funding have been screened. Eligible applications are to be ranked by March 10, 2017. There are currently 201 eligible or pending (lacking one or more eligibility requirements) EQIP and 26 AMA applications in the District. Focused Conservation Approach applications total 6 in Pocahontas County and 19 in Greenbrier. Due to the overlap of practices available in different fund pools, some applications may be entered into more than one pool. Applications may also drop out if eligibility is not established by cut-off dates.

The Appalachian Environmental Restoration Initiative (AERI), which replaced the West Virginia Restoration Venture (WVRV) this year has been expanded to include all of Monroe County. There are currently 12 applications for AERI in Pocahontas County, 23 in Greenbrier, and 61 in Monroe County. Other significant fund pools include High Tunnels with about 54 applications, Forestry with 5 applications, High Tunnel Irrigation with 4 applications and Wildlife with 2 applications.

Should funds be available, the application cut-off date for the second and third rounds of funding are February 28, 2017 and May 31, 2017.

*CSP* - Contract holders who wish to be paid in 2017 for FY2016 activities must present their documentation and be paid prior to March 15. The 2017-1 signup ended on February 3, and applications are to be ranked by March 10, 2017.

*NWQI* - Lee Godbey, Dennis Burns, myself and other staff have been participating in teleconferences regarding the National Water Quality Initiative Indian Creek (Burnside Branch) watershed project.

### Personnel/Other

- Susan Davis has accepted a position outside of the Federal realm with Dominion Energy as their Senior Environmental Compliance Coordinator. Through Susan's 26 years of service with NRCS she has provided quality conservation services to countless individuals always with a smile. She will be missed by all who have worked with her.

- Adam has been supervising EWP jobs almost exclusively for several weeks.

### **Request to Conservation Districts**

The WVCA is encouraging Conservation Districts to review and update your District Policy Manuals. In addition to your policy manual you are encouraged to review your CD Employee Manual (if you have one) and your CD Plan of Work. If you are already doing these reviews, please disregard this request.

The district personnel plan is due to SCC in March, so please add to your February agenda for review and approval.

### AGEP:

### **Conservation Farm Tour**

It is time for districts to be thinking about the farm families to be awarded. The awards council voted at its January 24 meeting to begin the process of reviewing the current format with potential recommendations for change. Tim VanReenen was elected as the awards council vice president and will work with Brian on gathering a committee to review the awards process.

### WVACD Scholarship

Applications are due to the district offices by the **first Monday in March**. All entries must be date stamped at the district office and mailed to the WVACD office by the third Monday in March. Contact Mark Fitzsimmons, WVACD Education Committee Chairman, for additional information.

### WVCA Strategic Plan

The State Conservation Committee has approved a motion to review the WVCA Strategic Plan. Brian is working with Tim VanReenen to select representatives from the Association to serve on the oversight committee. A series of meetings will be planned for late spring, early summer.

### **Engineering Expression of Interest**

Review your current contract and if needed, prepare to advertise and go through interview/selection process if needed.

The WVCA is interested in working with the district to ensure they retain a firm that has strong civil engineering and is familiar with dams. Under our 50/50, 5-year agreement with NRCS this will be important because we hope to work with the district's engineering firm to perform engineering work on dams if necessary.

Because of questions raised about these agreements, it's important to make sure that the scope of work is clearly defined and an agreement between the district and engineering firm is signed.

Also, the district may want to consider whether it wants an engineering firm that also has the ability to perform environmental assessments.

### WVCA Project Section:

EWP

- Planned work:
  - Debris contracts are complete in Greenbrier, Webster and Nicholas and Clay Counties. The total for the first round of debris removal was \$1,203,763.22.
  - Working with NRCS, we have identified 62 eligible bank stabilization sites. These projects include the installation of rip rap/gabions. NRCS is doing the contracting for these projects. The first contracts are in the process of being awarded.
  - Working with counties, we are identifying streams that have limited capacity due to sedimentation (Roane, Greenbrier, Webster and Kanawha). The Corp is currently reviewing permit applications for this work. These projects are contingent upon funding.
  - Work continues on Howard's Creek through the town of Caldwell.
  - Work is starting on the Howard's Creek flood control channel at White Sulphur Springs. This work is being contracted by NRCS.
  - Surveying is underway to develop a scope of work for the Rainelle Flood Control Channel Project.

### OM&R

- Project Section staff is performing monthly and quarterly inspections of watershed dams. The total spent on O&M for calendar year 2016 is \$686,315.15. Yearly summaries will be provided to each district.
- Work continues with NRCS to develop engineering plans for watershed dams. The seep investigation work being conducted by CEC in South Fork is currently underway.
- The Harmon Creek (NPCD) contract is moving forward, work on the seep box on site 13 is underway.
- Attached is the annual inspection date for the North Area. The schedule for the South Area is in planning.

Dam Rehab

- Gannett Fleming is continuing to work on planning studies for Brush Creek 9 & 15 and New Creek 1 & 17, and perform the construction oversight for UDC1.
- Upper Deckers 1

- The contract and permit process is beginning for UDC1 with construction slated for 2017/2018.
- WVCA is preparing the permit applications and mitigation plan as well as preparing the contract.
- The scoping meeting for New Creek 1 is scheduled for February 16, 2017 at Potomac State College.
- NPCD, SCD, MCD and PVCD Please track hours that District Supervisors attend any rehab meetings.
- Reminder: Rehab meetings are held the first Wednesday of each month. Any District that has rehab projects can participate in these meetings by phone.
