## **Request to Conservation Districts**

The WVCA is encouraging Conservation Districts to review and update your District Plan of Work. Plans are due to Guthrie by June 15.

### **Conservation Farm Tour**

Due to COVID-19 the farm tour will at least be pushed back if not cancelled completely this year.

In recent discussions on how to revive the contest, it has been suggested that it be changed to every other year. This move might increase district participation.

The next consideration is what to do this October to replace the awards banquet? A suggestion would be to hold an Association/SCC convention that would feature past award farmers to lead panel discussions on conservation BMPs, experts in the field to talk about conservation trends and opportunities and invite national conservation leaders to make addresses.

West Virginia has also been asked to host a listening session on small watershed dams, and that might be incorporated into this meeting as well.

### **District Personnel Plan**

District Personnel Plans were due to the SCC by **March 1**. Failure to meet the deadline may cause a delay in approving the District's personnel plan and the release of state funds for those positions. If you have not submitted, please do so ASAP.
