She noted that they have approximately 68 designs, with 21 currently in limbo. She reported on recent funding cuts, which affect the agreements for ACES employees. Additionally, she reported that no applications have been received for the District Conservationist position in Lewisburg for Greenbrier North, under the critical vacancy announcement opportunity. Furthermore, she noted that applications for the first round of funding for program year 2026 are due by August 29; late applications will be rolled into the second round or later.
