Description, Purpose and Policy

1. Cost-Share payments are provided for removal of excess litter from the Chesapeake Bay watershed.
2. Cost-Share is provided at a flat rate of \$10.00 per ton incentive to encourage transport of excess litter out of the Chesapeake Bay watershed.
3. The PVCD AEP committee requires certified scales weigh ticket for each load transferred out of the watershed.
4. A W-9 tax form will be required with application for District tax purposes.
5. Cost -Share is available to poultry producers only.
6. Practice must be completed and weigh tickets submitted by **June 30, 2027, 4:00 PM.**
7. No duplication of federal or state cost-share shall be allowed.
8. Applicant must be a District Cooperator.



Payment rates and limits

1. Rate is set at \$10.00 per ton with max of 250 tons.
2. Max incentive payment of \$2,500 per producer.
3. Program is open to all producers.
4. Approvals will be made based upon **available funds.**
5. Higher priority will be given to producers with excess litter identified in their NMP and first come first serve basis.
6. Recipients of litter are to sign and give physical address of the litter's final destination.
7. Each load transferred out of watershed is to have a weigh ticket to confirm amount transferred.
8. Producers of litter are required to have a current litter analysis (1Yr).
9. Producers of litter are required to have a current NMP (3Yr).
10. **All litter must be transferred out of the Chesapeake Bay watershed to qualify for incentive payment.**
11. The payment will be made **within 45 days** after weigh tickets and verification of transfer are received, cooperator completes a W-9 form and funding is available.
