Rooms will be assigned to teams upon arrival at the event. Room assignments are prioritized based upon order of forms received. *There will not be co-ed buildings. Everyone must bring their own toiletries, towels, and linens. Pillows are provided. Adults and students will lodge in the same cabin unless special arrangements are required..
